INFORMATION CLAUSE CONCERNING THE PROCESSING OF PERSONAL DATA

Pursuant to Art. 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council (General Data Protection Regulation, hereinafter referred to as the GDPR), we would like to inform you that:

1. The Controller of your data is Wrocław Medical University, with its registered office in Wrocław 50-367 at ul. Wybrzeże Pasteura 1, hereinafter referred to as the "Controller", represented by the Rector;
2. The Controller has appointed a Data Protection Officer, who can be contacted at the following email address: iod@umw.edu.pl in relation to all issues associated with the processing of personal data;
3. Your personal data will be processed for the purposes of initial recruitment to the Ed practical training and for sending information concerning the commencement of the proper recruitment to the email address provided;
4. The legal basis for the processing of personal data is: Art. 6 sec. 1 letter a) of the GDPR, i.e. consent to the processing of your personal data, given by submitting the form.
5. The Controller does not make your personal data available to any recipients, except for cases where such obligation results from generally applicable law;
6. The Controller may entrust another entity, by means of a contract concluded in writing, with the processing of your personal data on behalf of the Controller, in particular teaching and IT service providers.
7. The Controller will store your personal data for a period of time necessary to achieve the purposes of the processing, but not longer than until the consent is withdrawn. The consent may be withdrawn by sending an email to: podyplomowe-ckp@umw.edu.pl;
8. In the cases, under the terms and in the manner specified in applicable regulations, you have the right to: access your data and rectify them (Art. 15 and 16 of the GDPR), erase your data (Art. 17 of the GDPR), limit the processing of your data (Art. 18 of the GDPR), object to the processing of your data (Art. 21 GDPR), transfer your data (Art. 20 GDPR) and withdraw your consent at any time. The withdrawal of consent shall not affect the lawfulness of the data processing which was carried out based on the consent prior to the withdrawal thereof;
9. You have the right to file a complaint with the Supervisory Authority: the President of the Personal Data Protection Office, ul. Stawki 2, 00-193 Warsaw if you suspect that your personal data are processed by the Controller in violation of the law;
10. The provision of your personal data is not obligatory; however, it is necessary for Wrocław Medical University to send information concerning the commencement of the recruitment. The refusal to provide data will prevent you from receiving the above information in due course.
11. Your personal data are not subject to automated decision-making, including profiling, referred to in Art. 4 point 4) of the GDPR, which is a form of automated processing of personal data consisting in using personal data to evaluate certain personal aspects of a natural person.
